## HOLD HARMLESS RELEASE

**DOUBLE DOG DAY CARE**, its owner, employees, representatives or any other person(s) affiliated with the company shall hereinafter be referred to as **DDDC**.

By signing this form, YOU: (print name) \_\_\_\_\_, hereinafter referred to as CLIENT, agree not to hold DDDC liable or sue for any injuries to and/or death of your dog(s):  
(list dogs) \_\_\_\_\_ while on the premises for indoor recreation and/or in the care of DDDC.

Although DDDC screens all dogs for temperament, does not take aggressive dogs and watches the dogs carefully, I understand that day care and recreation can be hazardous due to dogs playing together. I will not hold DDDC responsible for injuries to my dog(s) and/or death that may occur in and out of the day care or during indoor recreational play. I also understand that the non-slip rubber floor, while providing a very good playing surface, may cause blisters to appear on the pads of my dog's(s') feet. If the staff of DDDC notices my dog(s) limping or favoring a paw, they will make a reasonable attempt to reduce its activity level, but are not otherwise liable.

If in my absence, my dog should become ill or injured, or need veterinary care, DDDC has my permission to consult with my veterinarian and I realize DDDC will make a reasonable effort to bring my dog to my veterinarian. If my dog should need immediate care, I hereby give DDDC permission to take my dog to the nearest veterinarian or emergency animal clinic. I understand that I am responsible for all veterinary costs, including the transportation of my pet to and from the veterinarian and/or clinic.

I understand that my dog will be taken outside on a regular basis while at DDDC and will be wearing a choke chain collar as backup method for safety. If I object and insist that a choke chain collar not be used on my dog, I will not hold DDDC responsible if my dog should get loose or lost while outside.

I hereby declare that my dog is not known to be aggressive toward other dogs or people. If my dog is aggressive while at DDDC I agree to pay all medical bills associated with the incident (for injuries to people and/or other animals).

I hereby declare that my animal has not been exposed to any communicable diseases within the last 30 days and is fully vaccinated in accordance with DDDC's policy.

I understand that DDDC cannot be held responsible for lost, dirty, damaged or destroyed belongings left at DDDC.

## DOUBLE DOG DAY CARE POLICIES

1. **Temperament** All dogs must complete a temperament evaluation. DDDC reserves the right to refuse any dog that might be a safety hazard to itself, other dogs in our care, or staff members. This includes, but is not limited to, dogs who are aggressive, anti-social, toy or people aggressive, anxious or physically ill. All dogs must have completed the first round of vaccinations. We will accept non-neutered males and intact females, but no females in heat are permitted. We do not allow Pit Bulls into our facility.
2. **Vaccinations** All dogs must have current vaccination against Rabies, Bordatella and an annual shot (e.g. DHLPP). Your dog will not be admitted into DDDC without proof of vaccinations.
3. **Flea Protection** All dogs are required to be on a veterinarian-approved form of topical flea control. No dogs with fleas will be permitted in our facility.
4. **Heartworm** All dogs must be on a veterinarian-approved heartworm preventative, such as Heartguard, Heartguard Plus or Revolution.
5. **Collars and Leashes** All dogs must be on a leash when entering and exiting DDDC.
6. **Feeding** We do not feed dogs while at day care, as food leads to problems with possessiveness and aggression. If, however, your dog must be fed while in our care, there will be a service fee of \$5 and you must provide the food and bowl.
7. **Toys and Beds** We do not allow toys and beds from home as dogs may become possessive of their personal belongings.
8. **Service Fees** Payment is expected at the time service is rendered. We accept cash, checks, Visa and MasterCard (debit and credit).
9. **Early / Late Fees** Early drop off (prior to stated opening time) is available for a fee of \$5. If you arrive after the stated closing time to pick up your dog, you will be assessed a fee of \$1 for every minute past closing unless arrangements have been made in advance.
10. **Equipment and Use of the Facility** The toys and equipment are intended solely for use by dogs. While DDDC certainly encourages families to enjoy time with their dog and permits children, DDDC is not responsible for their safety or liable in any way for any injuries that may occur. DDDC reserves the right to eject parties exhibiting unruly or disruptive behavior.
