HOLD HARMLESS RELEASE

DOUBLE DOG DAY CARE, its owner, employees, representatives or any other person(s) affiliated with the company shall hereinafter be referred to as **DDDC**.

By signing this form, you: (print name) _____, agree not to hold DDDC liable or sue for any injuries to and/or death of your dog(s) while on the premises of DDDC.

Although DDDC screens all dogs for temperament, does not allow in dogs known to be aggressive, and watches the dogs carefully, I understand that interaction between dogs can be hazardous to dogs as well as people. I will not hold DDDC responsible for injuries to my dog(s) and/or death that may occur in day care or the grooming salon, during indoor recreational play or classes. I also understand that the non-slip rubber floor, while providing a very good playing surface, may cause blisters to appear on the pads of my dog's(s') feet. If the staff of DDDC notices my dog(s) limping or favoring a paw, they will make reasonable attempts to reduce its activity level, but are not otherwise liable.

If in my absence my dog should become ill, injured or in any other way need veterinary care, DDDC has my permission to consult with my veterinarian. If my need should need immediate care, I hereby give DDDC permission to take my dog to the nearest veterinarian or emergency animal clinic. I understand that I am responsible for all veterinary costs, including the transportation of my dog(s) to and from the veterinarian and/or clinic.

I hereby declare that my dog is not known to be aggressive toward other dogs or people. If my dog intentionally causes injury to another dog or person while at DDDC I agree to pay all medical bills associated with the incident.

I hereby declare that my dog(s) has (have) not been exposed to any communicable diseases within the last 30 days and is fully vaccinated in accordance with DDDC's policy, and that I will keep my dog(s)'s vaccines current.

I understand that DDDC cannot be held responsible for lost, dirty, damaged or destroyed belongings left at DDDC.

DOUBLE DOG DAY CARE POLICIES

1. **Temperament** All dogs must complete a temperament evaluation. DDDC reserves the right to refuse any dog that might be a safety hazard to itself, other dogs in our care, customers or staff members. This includes but is not limited to dogs who are aggressive, anti-social, to or people aggressive, anxious or physically ill. All dogs must have completed the first round of vaccinations and remain current. We reserve the right to charge a \$5 service fee for non-neutered males who mark excessively.
2. **Vaccinations** All dogs must have current vaccinations against Rabies and Bordatella and an annual shot (e.g. DHLPP). Your dog will not be admitted into DDDC without proof of vaccinations. Dogs must remain current on all vaccines.
3. **Flea Protection** All dogs are required to be on a veterinarian-approved form of flea control. No dogs with fleas will be permitted in our facility.
4. **Heartworm** All dogs must be on a veterinarian-approved heartworm preventative.
5. **Collars and Leashes** All dogs must wear a collar and be securely leashed when entering and exiting DDDC.
6. **Feeding** We discourage feeding while at day care as food leads to problems with possessiveness. If, however, your dog must be fed while in our care, you must provide the food and bowl, and we reserve the right to charge a service fee.
7. **Toys and Beds** We do not allow toys and beds from home to be brought in as it may lead to possessiveness.
8. **Payment for Services** Payment is expected at the time service is rendered unless other arrangements have been made. We accept cash, checks and major credit cards.
9. **Early / Late Fees** Drop off prior to stated opening time and pick up past the stated closing time is available for a fee per quarter hour. Arrangements for early drop off or late pick up must be made in advance.
10. **Use of equipment and facility** The toys and equipment are intended solely for use by dogs. DDDC is not responsible for the safety of adults or children or liable in any ways for any injuries that may occur while on our premises. DDDC reserves the right to eject parties exhibiting unruly or disruptive behavior.
